Hearing on Petition for Annexation of Territory into the Harbor Water PUD

The principal Act of the Harbor Water PUD is ORS chapter 261. That Act allows additional and cumulative to laws for annexations to districts. Under ORS 261.141, annexation may be initiated by Resolution of the Board of Directors of that District.

The Curry County Board of Commissioners will take public testimony at the hearing. The board shall consider whether area could be benefitted and consider local comprehensive plan. The County will determine the boundaries of the district and establish a date for a final hearing on approval of the annexation.

Any person interested in the proposed annexation may appear and present written statements for or against the granting of the petition or the proposed change. A written statement for or against a proposed formation or change of organization or a request for an election must be in writing, must clearly specify the defect, error, irregularity or omission to which objection, if any, is made and must be filed within the time and in the manner provided by ORS 198.705 to 198.955. Any statement not so made and filed shall be considered voluntarily waived.

Territory annexed shall become subject to outstanding indebtedness, bonded or otherwise of the district in like manner with territory within the district. Annexation will not impair the rights of any bondholder or creditor of the district. Bondholders or creditors of the district may enforce rights against territory annexed. Annexation shall not affect or impair the title to any property owned or held by the district, or any debts, demands, liabilities or obligations existing in favor of or against the annexed property.
