MINUTES BUSINESS MEETING August 4, 2021

1. CALL TO ORDER & PLEDGE OF ALLEGIANCE

The meeting was called to order by Chair Boice at 9:01 a.m. Present were Chair Court Boice, Vice Chair John Herzog, and Commissioner Chris Paasch.

Also present: Legal Counsel Anthony Pope and Administrative Assistant John Jezuit.

The Pledge was recited by all.

Boice gave the line of duty casualty report, a COVID-19 pandemic report, and a fire report.

7I. Sheriff's Department Planning - Commissioner Paasch

Sheriff Ward gave detailed information about a large marijuana grow in south county, the damage the grow does to the environment, and safety issues faced by the deputies. A discussion with Boice; Becky Crockett, Planning Director; Herzog; Hunter; Paasch; and Ward about the dangers involved, forming a task force with other counties to respond, and contacting the landowners followed.

B. Roadmaster Signature Authority to Purchase \$475,954.78 Sewer Equipment 900-ECO 9 Yard Truck Mounted Combination Sewer Cleaner – Richard Christensen, Roadmaster Christensen described the workings and efficiencies of the Vactor truck and noted its advantages and benefits to the County. A discussion with Boice, Christensen, Herzog, and Paasch ensued. Tom Hochmuth (via GoToMeeting), Regional Sales Manager, Sewer Equipment Company of America, explained the warranties.

Motion by Herzog, seconded by Paasch, to approve Roadmaster signature authority. Motion carried unanimously.

C. Roadmaster Signature Authority to Award Capitol Asset & Pavement Services Inc. for the Roadside Digital Video Image Agreement in the Amount of \$17,900 – Richard Christensen, Roadmaster

Christensen described the equipment and what it does.

Motion by Paasch, seconded by Herzog, to approve Roadmaster signature authority. Motion carried unanimously.

D. Roadmaster Signature Authority to Purchase Eleven (11) New Ram Quad Cab 4X4's through Enterprise Fleet Replacement Program for the Road Department in the Amount of \$335,519 - Richard Christensen, Roadmaster

Christensen stated he is not a fleet manager, commented on maintenance costs, and recommended moving forward with equity plan and full purchase. A discussion with Boice, Christensen, Herzog, and Paasch about the advantages and disadvantages of moving forward, number of vehicles to purchase, and the Road Department budget followed. Paasch disagreed with the process.

Motion by Herzog, seconded by Boice, to approve eleven (11) vehicle Roadmaster signature authority. Motion carried 2-1 (Boice – Yes; Herzog – Yes; Paasch – No).

E. Roadmaster Signature Authority to Sell Five (5) General Service Vehicles through Enterprise Fleet Management – Richard Christensen, Roadmaster

A discussion with Boice, Christensen, and Sheriff Ward ensued. Boice stated he does not want to make a decision on this today.

Motion by Paasch, seconded by Herzog, to sell five (5) vehicles but switch out the Jeep and Toyota with the Sheriff's Department. Motion carried 2-1 (Herzog – Yes; Paasch – yes; Boice – No).

F. Roadmaster Signature Authority to Purchase Seventeen (17) New Ram Quad Cab 4X4's and Three (3) Dodge Durango's through Enterprise Fleet Replacement Program in the Amount of \$562,589 for General Services Department – Richard Christensen

A discussion with Boice, Christensen, Herzog, and Paasch about the number of vehicles, benefits, costs, and timelines followed.

Motion by Herzog, seconded by Boice, to purchase ten (10) vehicles through the Enterprise Fleet replacement program. Motion carried unanimously.

G. Curry County Will Not Accept Additional- No More State "Lockdowns" on our Citizens or Businesses without Prior Curry Board of Commissioners Approval - Commissioner Boice Boice explained and read the resolution.

Motion by Paasch, seconded by Herzog, to approve resolution. Motion carried unanimously.

H. Appoint Fair Board Member - Commissioner Herzog

The Board chose to appoint Scott Mickelson to the Fair Board. Motion carried unanimously.
